1. Registration is only open to craftspeople and designers who work **professionally** on contemporary design and production of consumer goods and applied arts in the area of unique copies and limited-lot production.
2. You may submit a maximum of one to three works, none older than two years, to the **Theme Exhibition**.
3. Hobby craftspeople and retailers are not admitted.
4. The exhibitors themselves are responsible for insuring their exhibition copies in the gallery and the open-air exhibition.
5. **Personal delivery** or posting of items for the **Theme Exhibition** in the week of **5th March to 9th March 2018**. *For personal delivery, please get in touch over the phone beforehand!*

6. **Setup** of the Theme Exhibition in the Galerie Altes Rathaus is being carried out by the organisers.
 7. All submitted works should be clearly labeled with **name** and **selling price** and a **supply list** must be attached to the description.
 8. The **accounting** takes place after the event. A provision of 20 % of the selling price is calculated for items in the Theme Exhibition.
 9. **Collection** of works is directly after the end of the exhibition on Sunday 22th April 2018 from 6 pm to 7 pm and on Monday 23th April 2018 from 10 am to 1 pm in the Galerie Altes Rathaus, Bergstraße 1, Worpswede.
 10. If **return shipment** is wanted: Freight and postage costs are to be taken care of by the exhibitor. Attach postage and return consignment note.
 11. Attendance is not necessary during the exhibition, but participation at gallery supervision would be greatly appreciated.

12. **Open-Air Exhibition:** Setup times are Friday 20rd April from 4 pm to 8 pm and Saturday 21th April from 7 am to 10 am. Please empty cars quickly and park them on the exhibitor parking space.
 13. The position of the stands is being decided upon by the organiser, and are subject to change. The organiser's directions need to be followed.
 14. The exhibition space is being guarded in the nights of Friday to Saturday and Saturday to Sunday. However, the organiser does not take any responsibility for damage or loss of works, stands or personal items. There is no insurance cover provided by the organiser. Insurance is to be taken care of by the exhibitor.
 15. Stands are to be brought along by the exhibitor. The stands need to look neat and tidy.
 16. All stands shall display name and address of the studio.
 17. Exhibitors look after their stands themselves and sell on their own account. All displayed products require price tags.
 18. People causing damage to the exhibition area, the facilities or the event area are liable themselves.
 19. The event area has to be kept clean. Dispose of your waste yourself.
 20. Takedown of the Open-Air Exhibition: Sunday 22 April from 6 pm
 21. The **participation fee** for the ARTS AND CRAFTS DAYS WORPSWEDE is **150 €** for the Theme Exhibition and the Open-Air Exhibition. The fee is to be paid after reception of the invitation, and counts as confirmation of participation.
